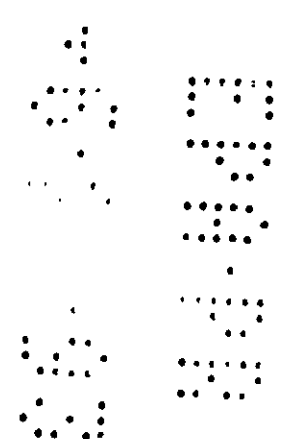
In this notification we are informing the Agency of two changes in the "Environmental Hazards" section of the currently accepted labeling for this product. These changes are described as follows:
