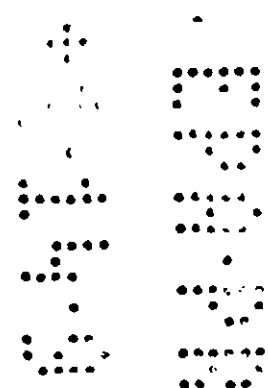

**APPLICATION:** BAYLETON fungicide is absorbed rapidly and works systemically from within the plant. Rainfall or sprinkler irrigation soon after application will assure rapid systemic uptake. Control will be less effective on turf suffering from drought stress. Therefore, in order to achieve maximum control, plants should be maintained in

a vigorously growing state through good cultural practices.

Apply when the turf is fully established and actively growing. Applications should be applied at recommended intervals to maintain disease control.

## STORAGE AND DISPOSAL
