

## PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

### CAUTION

If swallowed, administer water freely and induce vomiting by giving one dose (1/2 oz or 15 mL) of syrup of ipecac. If vomiting does not occur within 10 to 20 minutes, administer second dose. If syrup of ipecac is not available, induce vomiting by sticking finger down throat. Repeat until vomit fluid is clear. Never give anything by mouth to an unconscious person. Get medical attention immediately.

If on skin, wash skin immediately with soap and warm water. If irritation occurs, get medical attention.

If eyes are contaminated, wash with plenty of water for at least 15 minutes. Get medical attention.

If inhaled, remove to fresh air. If not breathing, give artificial respiration, preferably mouth to mouth. Get medical attention.

APPLICATION: BAYLETON fungicide is absorbed rapidly and works systemically from within the plant. Rainfall or sprinkler irrigation soon after application will assure rapid systemic uptake. Control will be less effective on turf suffering from drought stress. Therefore, in order to achieve maximum control, plants should be maintained in a vigorously growing state through good cultural practices.

Apply when the turf is fully established and actively growing. Applications should be applied at recommended intervals to maintain disease control.

Do not use on crops grown for food or forage.

### STORAGE AND DISPOSAL
