NOTE: PINE TREE DECLINE (suppression of symptoms)

Use 1.3 ml of BAYLETON 009 EC per inch of trunk circumference. Apply using a low pressure trunk injection system. Place injectors evenly around the circumference of the trunk 4 to 5 feet from the base of the tree. Use one injector site per inch of trunk diameter. In addition to the BAYLETON 009 EC being used, a liquid fertilizer solution containing 1% iron plus 1% zinc in chelated form should be combined on a 1 to 1 ratio with the BAYLETON 009 EC and injected at the required rate for BAYLETON.

Applications should be made from mid-November to mid-March in Florida. In other geographical areas a_r , lications should be made when resin flow will not impede the injection and release of the BAYLETON 009 EC.

<u>APPLICATION RATES</u>: Except as noted for specific diseases, mix 1 to 2 tablespoonfuls (0.5 to 1 fl. oz.) BAYLETON 009 EC in 1 gallon of water and apply as a full coverage foliage spray to the point of drip as needed.

*Hix 2 to 4 fl. ozs. of BAYLETON 009 EC in 1 gallon of water and apply as a full-coverage foliar spray to the point of drip. Applications for flower blight should begin at the expanded bud stage (color showing). Use multiple applications at 7-to 14-day intervals as needed dependent upon bloom periods.

**Mix 4 fl. ozs. of BAYLETON 009 EC plus sufficient spreader sticker for good coverage in 1 gallon of water. Apply in a spray application to the point of run-off on an as needed basis. Excessive rates or excessive applications may result in a shortening of the flower stalk on iris.

***Mix 2 to 4 fl. ozs. of BAYLETON 009 EC in 1 gallon of water and apply as a full coverage foliar spray to point of run-off. Apply in early spring as growth starts and reapply on a 14- to 21-day interval until new growth is fully expanded. Protect new growth that develops in late summer or fall as temperatures begin to drop.

Mix specified amount of BAYLETON 009 EC in 1 gallon of water and apply in a spray application to the point of drip. Intervals between applications should be no shorter than 30 days to avoid flower stalk length reduction. Excessive rates or applications may result in a shortening of the flower stalk.

COMPATIBILITY: BAYLETON 009 EC is compatible with many registered insecticides and fungicides. To determine the compatibility of BAYLETON 009 EC with specific products, the following procedure should be conducted. Pour the recommended proportions of the products into a suitable container of water, mix thoroughly and allow to stand at least 5 minutes. <u>SPRA" ADDITIVES</u>: Use of various spray additives such as spreader stickers or fertilizers should be evaluated prior to use. The label directions given here are base on data obtained with no additives; use of any product with BAYLETON 009 EC may affect the result. Contact local university extension personnel prior to use of spray mix additives.

<u>RESTRICTIONS</u>: Edible portions of treated trees, such as nuts and syrup, should not be used for feed or food.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Household: Do not reuse empty container. Securely wrap original container in several layers of newspaper and put in trash collection.

Pesticide Disposal (Except Household): Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

Container Disposal (Except Household): Iriple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or incineration, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.
