### **GENERAL INFORMATION**

TEMPO 20 WP T & O Insecticide contains 20% active ingredient which will provide effective knockdown and residual control of the pests listed in this label.

This package contains pre-measured 120 gram water soluble (PVA) packets of TEMPO 20 WP T & O Insecticide. Do not allow the inner packets to become wet before adding to the spray tank. Do not handle the clear inner packets of TEMPO 20 WP T & O Insecticide with wet hands or gloves. Rough handling may cause breakage. Do not store at temperatures below 32° F. Allow packages to warm above 50° F before use. Cooler water temperatures increase the time needed for the inner packet to dissolve completely.

TEMPO 20 WP T & O Insecticide is intended for use around buildings and structures, as well as on ornamentals and home lawns.

MIXING: The enclosed packets containing TEMPO 20 WP T & O Insecticide are <u>water soluble</u>. Do not allow packet to become wet prior to adding to the spray tank. Do not handle with wet hands. Reseal outer carton to protect remaining packets.

To prepare the spray mixture, drop the required number of unopened packets, as determined under use instructions, into the spray tank while filling with water to the desired level. Operate the agitator while mixing. Depending on the water temperature and the degree of agitation, the packets should be completely dissolved within approximately 5 minutes from the time they were added to the water.

### **OUTDOOR USE**

(general surface spray)

For control of: Cockroaches, ants, crickets, sowbugs, pillbugs, boxelder bugs, elm leaf beetles, spiders, centipedes, millipedes, ticks, flies, mosquitoes, midges, gnats, bees, wasps, yellow jackets, and hornets.

Mix one 120 gram packet of TEMPO 20 WP T & O Insecticide per 12.6 gallons of water, refer to General Information section for mixing instructions. Apply as a general surface spray using 1 gallon of suspension per 1000 square feet.

Make applications to outside surfaces of buildings, porches, patios, garages and other areas where these pests have been seen or found. To help prevent infestations of buildings by the above pests, treat a 5 to 10 foot band of soil, turf or other substrate adjacent to buildings and the building foundation to a height of 2 to 3 feet where these pests are active and may find entrance.

# RECOMMENDATIONS FOR ORNAMENTALS AND HOME LAWNS

When used at recommended rates and as directed under RECOMMENDED APPLICATIONS, TEMPO 20 WP T & O Insecticide will control the designated pests on trees, shrubs, foliage plants and flowers in outdoor landscaped areas such as parks, recreational areas, athletic fields, institutional grounds, etc., and in nurseries and greenhouses, and interior plantscapes (such as in hotels, shopping malls, office buildings, etc.) where these plants are grown. TEMPO 20 WP T & O Insecticide also controls designated pests in home lawns.

MIXING: Refer to General Information section for instructions.

APPLICATION: TEMPO 20 WP T & O Insecticide mixes readily with water and may be used in all types of spray equipment. Mix product with the required amount of water and apply as a dilute spray application to the point of run-off. When spraying hard-to-wet foliage such as holly, pine or ivy, the addition of a spreader/sticker may enhance both knock-down and residual activity. If concentrate or mist type spray equipment is used, an equivalent amount of product should be used on the area sprayed, as would be used in a dilute application. When mixing a concentrated suspension, additional time may be required to fully dissolve the PVA packet(s).
