

APPLICATION TO TURFGRASS

MERIT 0.5 G Insecticide can be used for the control of soil inhabiting pests of turfgrass, such as Northern & Southern masked chafers, Cyclocephala borealis, C. immaculata, and/or C. lurida; Asiatic garden beetle, Maladera castanea; European chafer, Rhizotrogus majalis; May or June beetles, Phyllophaga spp.; Japanese beetle, Popillia iaponica: Oriental beetle, Anomala orientalis; Billbugs, Spherophorus spp.; Annual bluegrass weevil, Hyperodes spp.; Black turfgrass ataenius, Ataenius spretulus; Aphodius spp; and Mole crickets, Scapteriscus spp. MERIT 0.5 G Insecticide can also be used for the suppression of cutworms in turfgrass areas. MERIT 0.5 G Insecticide can be used as directed on turfgrass in sites such as home lavins, business and office complexes, shopping complexes, multi-family residential complexes, golf courses, airports, cemeteries, parks, playgrounds, and athletic fields. MERIT Insecticide can not be used on commercial sod farms.

The active ingredient in MERIT 0.5 G Insecticide has sufficient residual activity so that applications can be made preceding the egg laying activity of the target pests.
