Your revised label for EPA Reg. No. 3125-472, dated March 5, 1999, has been reviewed. With respect to the changes made based on the recommendations of the Consumer Labeling Initiative (CLI) and the other non-CLI related changes, the proposed label is acceptable provided you modify the label as indicated below.

- 1. On the front panel of your proposed label, the word "NEW!" must be deleted since the product formulation has not changed. A product may only be referred to as "New" for a period of 6 months after initial registration or acceptance of a revised formulation. In this case, only the product labeling is being revised; the formulation has not changed.
- 2. Line 6 under the product name on the front panel must be changed to read:

"For Use On: Lawns, Ground Covers, Flower Beds, and around Trees and Shrubs."

3. The phrase "ADVANCED PROTECTION FORMULA" (line 7 on the front panel) must be deleted. This statement is a comparative advertising claim relative to effectiveness and may be false or misleading in comparison with other products that don't include such a statement on their labels. According to 40 CFR 156.10(a)(5), no advertising claims may be false or misleading in any way. In addition, claims that are exaggerated or unsubstantiated can not be made on the label. Please refer to 40 CFR 156.10(a)(5) for a more detailed explanation of what are considered false and misleading statements.

You have added numerous marketing claims to the front panel of your proposed label which were not included on previously accepted labels for EPA Reg. No. 3125-472. Although some similar marketing claims were included on the last accepted label for this product (stamped August 9, 1995), the additional proposed claims are not considered acceptable at this time and must be deleted from the label. Your application for amended registration indicated that the purpose of your application was to "propose revisions to the label in format and content in accordance with the most current recommendations of EPA's Consumer Labeling Initiative (CLI) Partners and Task Force." We note that the CLI was intended to provide an opportunity for revisions to the format and content of the labels of consumer-use products so that these labels would provide more usable information to consumers in a format that is easier to read and understand than the current format. The CLI should not be used as an opportunity to add marketing claims that have not been previously reviewed and accepted and may be considered false, misleading, or unsubstantiated according to 40 CFR 156.10(a)(5).

The current accepted label for this product, dated August 9, 1995, includes several marketing claims on the front panel that were previously reviewed and considered acceptable. At this time, only those claims that were previously accepted may appear on your revised CLI label. If you wish to add additional marketing claims to your label, please submit a separate application for amended registration with your proposed additional or revised claims clearly outlined on the revised label.

- 5. In the "Quick Facts" box on page 2 of your proposed label, the only new claim that is considered acceptable at this time is the claim "Easy-To-Use-Granules." The rest of the marketing claims are the same as the ones that appear on the front panel of your proposed label. As indicated in item 4. above, only those claims that appear on previously accepted labels for this product may be included on your revised CLI label at this time. Additional marketing claims not previously accepted must be deleted from the label.
- 6. The other CU-related label revisions, including the general format of the proposed label, the primary hazard statement associated with the signal word on the front panel, the ingredients statement on the back panel, and the proposed "First Aid" and "Storage and Disposal" directions are acceptable.

Since this product label may be used as an example of CLI recommended revision, please submit one copy of your revised final printed labeling before the product label is displayed to the public and before you release the product for shipment. If the above specified conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions. A stamped copy of the label is enclosed for your records. 

White grubs cause extensive damage to lawns by feeding on grass roots. Grass turns yellow, then brown, and dies. Grubs chew off roots so that the grass is easily pulled up in pieces with your hands. You can roll it back like a carpet to reveal the grubs. If patches of dead grass appeared in your lawn late last summer, check for grubs.

## SIGNS OF DAMAGE TO LAWNS (mole crickets)

Mole crickets often cause extensive damage by tunneling through lawns. Some species also feed on roots. Tunneling uproots the grass so it easily dries out. Lawns turn yellow, become thin, weedy, and can eventually die.
