MERIT 0.2 Plus Turf Fertilizer can be used for the control of soil inhabiting pests of turigrass, such as Northern & Southern masked chafers, Cyclocephala borealis, C. immaculata, and/or C. lurida; Asiatic garden beetle, Maladera castanea; European chafer, Rhizotrogus majalis; May or June beetles, Phyllophaga spp.; Japanese beetle, Popillia Japonica; Oriental beetle, Anomala orientalis; Billbugs, Sphenophorus spp.; Annual bluegrass weevil, Hyperodes spp.; Black turfgrass ataenius, Ataenius spretulus; Aphodius spp.; and mole crickets, Scapteriscus spp. MERIT 0.2 Plus Turf Fertilizer can be used as directed on turfgrass in sites such as home lawns, business and office complexes, shopping complexes, multi-family residential complexes, golf courses, airports, cemeteries, parks, playgrounds, and athletic fields. The active ingredient in MERIT 0.2 Plus Turf Fertilizer has sufficient residual activity so that applications can be

made preceding the egg laying activity of the target pests. High levels of control can be achieved when applications are made preceding or during the egg laying period. The need for an application can be based on historical monitoring of the site, previous records or experiences, current season adult trapping or other methods. Optimum control will be achieved when applications are made prior to egg hatch of the target pest, followed by sufficient irrigation or rainfall to move the active ingredient through the thatch.

Optimum control will be achieved when applications are followed by sufficient mechanical incorporation, irrigation or rainfall to place the active ingredient into the soil. Application should be made prior to anticipated pest infestation to achieve optimum levels of control.

Applications of MERIT 0.2 Plus Turf Fertilizer cannot exceed a total of 200 lb (0.4 lb of active ingredient) per acre per year.

#### APPLICATION EQUIPMENT
