If in eyes: Hold eyelids open and flush with plenty of water. Call a physician if irritation persists. If swallowed: Call a physician or Poison Control Center. Administer water freely and induce vomiting by giving one dose (1/2 oz or 15 ml) of syrup of ipecac. If vomiting does not occur within 10 to 20 minutes, administer second dose. If syrup of ipecac is not available, induce vomiting by sticking finger down throat. Repeat until vomit fluid is clear. Never give anything by

mouth to an unconscious person. Avoid alcohol. If on skin: Wash thoroughly with soap and water. Get medical attention if irritation occurs. If inhaled: Move victim to fresh air. If not breathing, give artificial respiration, preferably mouth-to-mouth. Get medical attention.

TO PHYSICIAN: No specific antidote is available. Treat the patient symptomatically with COMMENTS
