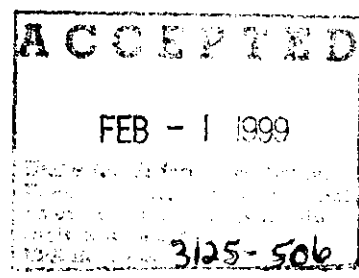

Immediately sprinkle gently but thoroughly with water.
