Dear Ms. Spagnoli,

This letter serves as addendum to our letters regarding EPA Reg. Nos. 3125-508 and 3125-504, dated May 19,1999. Our letters required that a "Note to Physician" statement be included on your revised CLI labels (item 9. in our letter for EPA Reg. No. 3125-508, and item 6. in our letter for EPA Reg. No. 3125-504). As discussed in our recent phone conversation, this requirement may be disregarded since neither of the two subject products meets the toxicity criteria for requirement of the statement and the active ingredient does not produce physiological effects requiring specific antidotal or medical treatment. We agree that a "Note to Physician" statement does not need to be included on your revised CLI labels. Subject: Merit 0.2 Granular Insecticide EPA Reg. No. 3125-508 Application for amended registration, dated March 5, 1999, to revise product label in accordance with Consumer Labeling Initiative recommendations and to change the product name.

Dear Ms. Spagnoli,

Your revised label for EPA Reg. No. 3125-508, dated March 5, 1999, has been reviewed. Your proposal to change the product name from Vision Grub Eliminator Ready-To-Use to Merit 0.2 Granular Insecticide is acceptable. With respect to the changes made based on the recommendations of the Consumer Labeling Initiative (CLI) and the other non-CLI related changes, the proposed label is acceptable provided you modify the label as indicated below.

- 1. On the front panel of your proposed label, the word "NEW!" must be deleted since the product formulation has not changed. A product may only be referred to as "New" for a period of 6 months after initial registration or acceptance of a revised formulation. In this case, only the product name and labeling are being revised; the formulation has not changed.
- 2. Line 6 under the product name on the front panel must be changed to read:

"For Use On: Lawns, Ground Covers, Flower Beds, and around Trees and Shrubs."

3. The phrase "ADVANCED PROTECTION FORMULA" (line 7 on the front panel) must be deleted. This statement is a comparative advertising claim relative to effectiveness and may be false or misleading in comparison with other products that don't include such a statement on their labels. According to 40 CFR 156.10(a)(5), no advertising claims may be false or misleading in any way. In addition, claims that are exaggerated or unsubstantiated can not be made on the label. Please refer to 40 CFR 156.10(a)(5) for a more detailed explanation of what are considered false and misleading statements.

You have added numerous marketing claims to the proposed label which were 4. not included on previously accepted labels for EPA Reg. No. 3125-508. Although similar marketing claims (discussed below under item 5.) were included on the last accepted label for this product (stamped June 12, 1998), the additional proposed claims are not considered acceptable at this time and must be deleted from the label. Your application for amended registration indicated that the purpose of your application was to 1) change the product name, and 2) propose revisions to the label in format and content in accordance with the most current recommendations of EPA's Consumer Labeling Initiative (CLI) Partners and Task Force. We note that the CLI was intended to provide an opportunity for revisions to the format and content of the labels of consumer-use products so that these labels would provide more usable information to consumers in a format that is easier to read and understand than the current format. The CLI should not be used as an opportunity to add marketing claims that have not been previously reviewed and accepted and may be considered false, misleading, or unsubstantiated according to 40 CFR 156.10(a)(5).

If you wish to add additional marketing claims to your label, please submit a separate application for amended registration with your proposed additional or revised claims clearly outlined on the revised label.

Also with respect to marketing claims, upon review of the current accepted label for this product, dated June 12, 1998, we noted that the label includes two marketing claims on the front panel that may be considered false or misleading and/or unsubstantiated according to 40 CFR 156.10(a)(5). Although the label was stamped "accepted," these statements should not have been accepted without comments. Since these claims appear on the current accepted label and may appear on your revised CLI label, we are providing the following comments regarding the claims on the current accepted label (dated June 12, 1998) at this time:
  - The statement "Just One Application Eliminates Grubs All Season" а. must be changed to "One Application Kills Grubs (and/or Mole Crickets) All Season." The word "eliminates" implies 100% efficacy and is considered misleading and unsubstantiated. Also, please note that any claim for insect control "all season" must be supported by data you have on file.
  - b. The claim "Long Lasting" is open-ended and can not be substantiated without a definition for what is considered "long lasting." You must either delete the claim "Long Lasting Effective Protection" or change the claim to "Highly Effective" (which was accepted on a previous label for this product, stamped November 25, 1997) or "Highly Effective in Reducing Grub/Mole Cricket Damage."
- 6. On the front panel of your proposed label dated March 5, 1999, change "TREATS 5,000 (10,000) SQ FT" to "TREATS 3,775-5,000 (7,550-10,000) SQ FT" so that the statement includes the coverage area for mole crickets.

7. In the "Quick Facts" box on page 2 of your proposed label, the only claim that is considered acceptable at this time is the claim "Easy-To-Use-Granules." The rest of the marketing claims are the same as the ones that appear on the front panel of your proposed label. As indicated in item 4. above, these claims are not considered acceptable at this time and must be deleted from the label.

- 8. On your proposed label dated March 3, 1999, the "PRECAUTIONARY STATEMENTS" and "ENVIRONMENTAL HAZARDS" appear at the top of page 2, above where the label indicates that the back panel begins. Move the block of "PRECAUTIONARY STATEMENTS" to the middle of the back panel, below the EPA Reg. No. and above the "First Aid" box. In addition, move the "ENVIRONMENTAL HAZARDS" block to the bottom of the back panel, below the "First Aid" box.
- 9. A "Note to Physician" statement must be included on your label. Although the CLI recommends that a toll-free number for emergencies may voluntarily be provided on the label, it does not specifically recommend that a toll-free number be added in lieu of the "Note to Physician." The following statement (as it appears on the current accepted label) must be added to your label, directly below the "First Aid" box:

"Note to Physician:No specific antidote is available. Treat the patient symptomatically."

10. The other CLI-related label revisions, including the general format of the proposed label, the primary hazard statement associated with the signal word on the front panel, the ingredients statement on the back panel, and the proposed "First Aid" and "Storage and Disposal" directions are acceptable.

Since this product label may be used as an example of CLI recommended revisions, please submit one copy of your revised final printed labeling before the product label is displayed to the public and before you release the product for shipment. If the above specified conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.



You can roll it back like a carpet to reveal the grubs. If patches of dead grass appeared in your lawn late last summer, check for grubs.

#### SIGNS OF DAMAGE TO LAWNS (mole crickets)


Mole crickets often cause extensive damage by tunneling through lawns. Some species also feed on roots. Tunneling uproots the grass so it easily dries out. Lawns turn yellow, become thin, weedy and can eventually die.
