
1. Reinstate the symptoms of poisoning following the First Aid statements.

Lawn diseases thrive in hot, humid temperatures and under/over fertilized lawn. Thatch build-up also contributes to the problem. Water your lawn in the early morning, never in the late evening. Have a soil test conducted to determine nutrient deficiencies. De-thatch whenever more than 1/2-inch exists. Mow often at a height recommended for your grass type and the season. 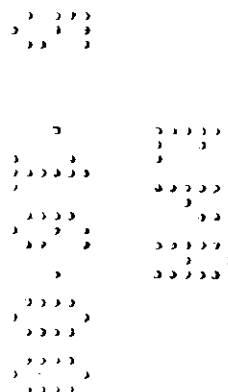

If your spreader is not listed, please call our toll-free Consumer Service hotline 1-877-BayerAL for help.

Settings are approximate. The condition of your spreader, the speed at which you walk and uneven terrain may affect the rate of application. Calibrate your spreader according to manufacturer's directions.

Do not use a spreader that applies granules in narrow, concentrated or uneven bands. Be sure the spreader works properly and spreads granules evenly.
