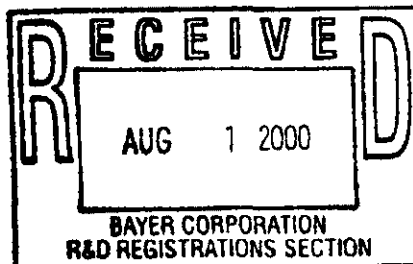


2. Submit two (2) copies of the final printed labeling for the record before you release the product for shipment.

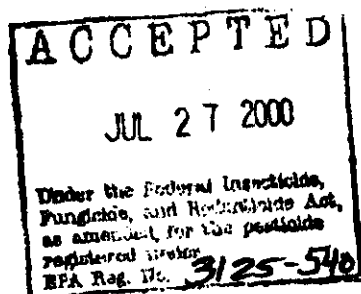
