GENERAL INFORMATION

Stratego is a broad spectrum fungicide for the control of certain diseases in corn, peanuts, pecans, rice and wheat Stratego, containing two fungicides, works both by interfering with respiration in plant pathogenic fungi and blocking fungal growth. Stratego is a potent inhibitor of spore germination and mycelial growth.

UNDER CERTAIN CONDITIONS CONDUCIVE TO EXTENDED INFECTION PERIODS, ADDITIONAL FUNGICIDE APPLICATIONS BEYOND THE NUMBER ALLOWED BY THIS LABEL MAY BE NEEDED. UNDER THESE CONDITIONS USE ANOTHER FUNGICIDE REGISTERED FOR THE CROP/DISEASE APPEARING ON THIS LABEL.

Resistance Management

The components in Stratego belong to two different chemistry classes. Trifloxystrobin belongs to the strobilurin class of chemistry which exhibits no known cross-resistance to other chemical classes including sterol inhibitors, dicarboximides, benzimidazoles, anilinopyrimidines, or phenylamides. Propiconazole belongs to the sterol inhibitor class. Because resistance development cannot be predicted, the use of this product should conform to resistance management strategies established for the crop and use area. Such strategies may include rotating and/or tank mixing with products having different modes of action; or limiting the total number of applications per season. Bayer Corperation encourages responsible product stewardship to ensure effective long-term control of the fungal diseases on this label.

Spray Equipment

Thorough coverage is necessary to provide good disease control. Applications using sufficient water volume to provide thorough and uniform coverage generally provide the most effective disease control. For ground application equipment, a minimum of 10 gals./A is recommended. For aerial application equipment, a minimum of 5 gals./A is recommended.

Equip sprayers with nozzles that provide accurate and uniform application. Be certain that nozzles are the same size and uniformly spaced across the boom. Calibrate sprayer before use.

Use a pump with the capacity to: (1) maintain a minimum of 35 psi at nozzles, and (2) provide sufficient agitation in the tank to keep the mixture in suspension - this requires recirculation of 10% of the tank volume per minute. Use a jet agitator or liquid sparge tube for agitation.

Use screens to protect the pump and to prevent nozzles from clogging. Screens placed on the suction side of the pump should be 16-mesh or coarser. Do not place a screen in the recirculation line. Use 50-mesh or coarser screens between the pump and boom, and where required, at nozzles. Check nozzle manufacturer's recommendations.

For information on spray equipment and calibration, consult sprayer manufacturers and state recommendations. For specific local directions and spray schedules, consult the current state agricultural experiment station recommendations.

Mixing Procedures

Prepare no more spray mixture than is needed for the immediate operation. Thoroughly clean upray equipment before using this product. Vigorous agitation is necessary for proper dispersal of the product. Maintain maximum agitation throughout the spraying operation. Do not let the spray mixture stand overnight in the spray tank. Flush the spray equipment thoroughly following each use and apply the rinsate to a previously treated area.

Additives: Do not apply Stratego in combination with organosilicate surfactants or crop injury may occur.

Stratego Alone: Add 1/2 of the required amount of water to the spray tank and start the agitator. Add the proper amount of Stratego and then add the rest of the water. Begin application of the solution when the Stratego has completely dispersed in the mix water. Maintain agitation until all of the mixture has been applied.

Stratego + Tank Mixtures: Add 1/2 of the required amount of water to the spray tank and start the agitator. In general, add tank mix partners in this order: products packaged in water-soluble packaging, wettable powders, wettable granules (dry flowables), liquid flowables, liquids, and emulsifiable concentrates such as Stratego. Always allow each tank mix partner to become fully dispersed before adding the next product. Continue to provide agitation while adding the remainder of the water. Maintain agitation until all of the mixture has been applied.

Note: When using Stratego in tank mixtures, all products in water-soluble packaging should be added to the tank before any other tank mix partner, including Stratego. Allow the water-soluble packaging to completely dissolve and the product(s) to completely disperse before adding any other tank mix partner to the tank.

If using Stratego in a tank mixture, observe all directions for use, crop/sites, use rates, dilution ratios, precautions, and limitations which appear on the tank mix product labet. No label dosage rate should be exceeded, and the most restrictive label precautions and limitations should be followed. This product should not be mixed with any product which prohibits such mixing. Tank mixtures, or other applications of products referenced on this label, are permitted only in those states in which the referenced products are labeled.

Stratego is compatible with most insecticide, fungicide, and foliar nutrient products. However, the physical compatibility of Stratego with tank mix partners should be tested before use. To determine the physical compatibility of Stratego with other products, use a jar test, as described below.

Using a quart jar, add the proportionate amounts of the products to 1 qt. of water. Add wettable powders and water-dispersible granular products first, next liquid flowables, then emulsifiable concentrates, and last, liquid soluble products. After thoroughly mixing, let stand for at least 5 minutes. If the combination remains mixed or can be remixed readily, it is probably physically compatible. Once compatibility has been proven, use the same procedure for adding required ingredients to the spray tank.

THE CROP SAFETY OF ALL POTENTIAL TANK MIXES INCLUDING ADDITIVES AND OTHER PESTICIDES ON ALL CROPS HAS NOT BEEN TESTED. BEFORE APPLYING ANY TANK MIXTURE NOT SPECIFICALLY RECOMMENDED ON THIS LABEL, THE SAFETY TO THE TARGET CROP SHOULD BE CONFIRMED.

Aerial Application: Avoid application under conditions where uniform coverage cannot be obtained or where excessive spray drift may occur. Do not apply directly to humans or animals.

Chemigation: Do not apply this product through any type of irrigation system.

Recommendations to Avoid Spray Drift

Do not make applications when conditions favor drift beyond the target application area. When drift may be a problem, take measures to reduce drift, including:

- (1) Do not spray if wind speeds are or become excessive. Do not spray if wind speed is 15 mph or greater. If nontarget crops are located downwind, use caution when spraying if wind is present. Do not spray if winds are gusty.
- (2) Use caution when conditions are favorable for drift (high temperatures, drought, low relative humidity).
- (3) Do not apply when a temperature inversion exists. If inversion conditions are suspected, consult with local weather services before making an application.

Do not apply more than 3 sequential applications of Stratego before alternating with a fungicide that has a different mode of action. Restrictions: Do not apply Stratego once the rice seed head has emerged. Do not apply more than 2 applications of Stratego or other stobiluron or shabiluron-containing fungicide per acre per year. Do not apply within 35 days of harvest. Do not apply more than 32 ft. oz. Statego per acre per year. Do not apply to stubble or ration crop rice. Do not use in rice fields where commercial farming of crayfish will be practiced. Do not drain water from treated rice fields into ponds used for commercial catfish farming. Do not use water drained from treated fields to irrigate other crops. Do not apply in CA.

Endangered Species Restrictions: The use of Stratego on rice is restricted to protect the endangered fat pocketbook pearly mussel (*Potamilus capax*) and its habitat. Use is prohibited in the following areas of AR:

Mississippi County - Within the basin that drains directly into the Right Hand Chute of Little River, south of Big Lake National Wildlife Refuge.

Poinsett County – Between Crowley's Ridge and the levee east of the Right Hand Chute of Little River and the St. Francis Floodway. Use is also prohibited west of Rt. 140 and north of Rt. 63 at the siphon near Marked Tree. Except that the prohibited area does not include the area bounded by Arkansas highway 373 on the west, highway 63 on the east, and highway 14 on the south.

Cross, St. Francis and Lee Counties – Between Crowley's Ridge and the levee east of the Right Hand Chute of Little River, and the St Francis Floodway, as far south as the confluence of L'Anguille River (Lee County).

Grazing Restrictions: (a). If 1 application or a total of 10 fl. oz of Stratego per season are applied, do not allow livestock to graze within the treated area within 30 days after application, and do not harvest the treated crop for forage within 30 days after application or for hay within 45 days after application. (b). If 2 applications or a total of 20 fl. oz. of Stratego per season are applied, as not allow livestock to graze within the treated area and do not harvest the treated crop for forage or hay.

Note: 10 fl. oz /A of Stratego is equivalent to 1.3 oz. of trifloxystrobin per acre.

Rotational Restrictions

Treated areas may be replanted immediately following harvest or as soon as practical following the last application with any crop listed on this label. The following crops may be replanted 30 days after the last application: celery, cereals, sweet corn, pineapple, and sugarcane. Soybeans may be planted as a double crop following a cereal crop that has been treated with STRATEGO. Do not use hay, forage or fodder from the soybean crop as any component of animal feed or bedding. For all other crops, a 105 day plant-back interval must be observed.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

Pesticide Storage: Store in a cool, dry place and in such a manner as to prevent cross contamination with other pesticides, fertilizers, food, and feed. Store in original container and out of the reach of children, preferably in a locked storage area.

Handle and open container in a manner as to prevent spillage. If the container is leaking, invert to prevent leakage. If container is leaking or material spilled for any reason or cause, carefully dam up spilled material to prevent runoff. Refer to Precautionary Statements on label for hazards associated with the handling of this material. Do not walk through spilled material. Absorb spilled material with absorbing type compounds and dispose of as directed for pesticides below. In spill or leak incidents, keep unauthorized people away. You may contact the Bayer Emergency Response Team for decontamination procedures or any other assistance that may be necessary.
