The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. One copy of the finished labeling must be submitted prior to releasing the product for shipment.

The ingredient statement must be revised as follows, with the ingredient percentages aligned with the ingredient names.

Technical Piperonyl Butoxide*

0.810%

Inert Ingredients**

Add to the directions for use the following statement:

In hospitals, patients should be removed from rooms prior to treatment. Rooms should be ventilated for two hours after spraying. Do not return patients to rooms until after ventilation.

If applicator is directly exposed to the fog, he should wear a dust/mist filtering respirator (MSHA/NIOSH approval number TC-21C).

Revise the sentence referring to crack and crevice treatment to read as follows: Using a hand sprayer, spray thoroughly into cracks, crevices and other places where insects may be harboring in order to contact as many as possible.

Move the word Caution from the directions for use to the Precautionary Statements.

Delete quotation marks wherever they appear on the label.

Delete the first sentence in the Pesticide Disposal Statement.

After the statement that the product is compounded especially for use in the fogging machine, add a statement that it is suitable for hand sprayers.

Compounded especially for use in the AERO-MASTER fogging machine.

Recommended for food processing plants, dairies, supermarkets, restaurants, clothing stores, warehouses, hospitals and schools.

CAUTION

"Foods should be removed or covered during treatment. All food processing surfaces should be covered during treatment or thoroughly cleaned with an effective cleaning compound and rinsed with potable water before reuse. When using this product in these areas, apply only when the facility is not in operation."

Avoid exposure to the fog. In operator is directly exposed to the fog, he should wear a mask. Do not remain in enclosed treated areas. Ventilate the area after treatment is completed.

Remove pets, fish and birds from areas to be treated.

For best results close all openings and turn off air conditioning and ventilating systems. Gas flames, pilot lights and other sources of open flames should be extinguished. After dispenser has finished operation, allow fog to completely settle before opening area.

FLIES, MOSQUITOES, GNATS AND FLYING MOTHS are killed almost immediately upon contact. Thoroughly fog area at the rate of 1 oz. per 1,000 cubic feet, and for maximum control keep area closed until fog has completely settled.

COCKROACHES, SILVERFISH AND GRANARY WEEVIL in warehouses, mills and stores can be killed only on direct contact in their exposed stages. Spray thoroughly into cracks, crevices and other places where insects may be harbored in order to contact as many as possible. Follow with a complete fogging of the area at the rate of 2 oz. per 1,000 cu. ft. Repeat application as necessary.
