DIRECTIONS:

For Dairy Cattle, Beef Animals:

To protect dairy and beef animals from face flies, house flies, stable flies, horn flies, mosquitoes and gnats, spray the animals daily using 1 to 2 ounces of vapona^(R) Stock Spray per head. Spray to thoroughly cover all parts of the animal, including the legs but do not wet the skin. Do not apply in excess of 2 fluid ounces per animal per day.

BARN FOGGING:

When a barn fogger is used to control face flies, house flies, stable flies, mosquitoes and gnats, fog 1 pint of Vapona^(R) Stock Spray for each 8,000 cubic feet of enclosure. Let fog settle before milking. DO NOT fog this solution over animals that have had direct application of this product within 8 hours.

FOR DAIRY BARNS, MILK HOUSES AND OUTDOOR AREAS: To control house flies, stable flies, mosquitoes and gnats dilute 1 part Vapona^(R) Stock Spray with 1 part spray oil and use as a coarse wet spray at the rate of 1 quart of diluted spray per 1,000 square feet. Treat around doorways, feed storage rooms, alleyways and window sills. Do not contaminate milk or milking utensils.
