



# CRABGRASS CONTROL FOR USE ON ALL BLADEGRASS LAWNS

CAUTION: May injure fine-bladed fescues and bentgrass. DO NOT USE ON DICHONDRA.


## WHEN TO APPLY

Super PAX Crabgrass Control is a pre-emergence control. It must be applied prior to crabgrass seed germination. The three-way action of Super PAX Crabgrass Control gives your lawn the early feeding it needs as well as controlling certain lawn insects.

# HOW TO APPLY FOR A BETTER LAWN:



Determine sq. ft. area to be covered (for Set spreader as recommended below. Fill example 40 x 50 ft.). One 14 lb. bag covers 2000 sq. ft. Super PAX will not burn when applied at recommended rate.



spreader where spilled material will not fall on lawn. Shake spreader to settle material. illustrated. Spreader settings below are for crisscross application.



Immediately after application wash Super PAX Crabgrass Control off the foliage with a medium spray from a hand-held nozzle. Make application in two crisscross coverages as Sprinkling systems and stationary sprinklers are less satisfactory. Do not water lawn for 12 hours after washing in, then resume normal watering practice.





# HOW TO APPLY FOR A BETTER LAWN:







Determine sq. ft. area to be covered (for Set spreader as recommended below. Fill spreader where spilled material will not fall on lawn. Shake spreader to settle material. Make application in two crisscross coverages as Sprinkling systems and stationary sprinklers are cross application.



Immediately after application wash Super PAX Crabgrass Control of the foliage with a medium spray from a hand-held nozzle. illustrated. Spreader settings below are for criss-less satisfactory. Do not water lawn for 12 hours after washing in, then resume normal watering practice.

## SUGGESTED SPREADER SETTINGS

Spreading rate may vary with the age, model, and condition of the spreader. Check your spreader by a trial over a known-size area. (14 lb. bag covers 2000 sq. ft.).

SETTINGS: Above settings are for crisscross application. If your spreader is not included above, set spreader opening at lowest setting which gives even flow, usually about 16 open. Spread in one direction and then crisscross. Continue crisscrossing until proper amount is applied. Broadcast spreaders are not recommended.
