CITRUS: (Grapefruit, Lemons, Limes. Oranges. Tangelos and Tangerines). Rust Mite—Use 5 to 10 pounds per 100 gallons water. During cool weather, use 10 lbs. of Standard Wettable Sulphur per 100 gallons water. At least 8 lbs. of Standard Wettable Sulphur should be used in miticidal sprays for the combined control of rust mite and purple mite.

PEACHES: Brown Rot. Powdery Mildew, Scab — 4 to 6 lbs per 100 gals water. Make applications during pink, petal fall and cover spray periods. Also as ripening of fruit approaches for Brown Rot control.

APPLES: Apple Scab, Powdery Mildew—6 to 8 lbs per 100 gals, water. Make application between periods of rainfall Repeat as necessary to cover new foliage growth during pink, petal fall and cover spray periods.


