citrus (Grapefruit, Lemons, Limes, Oranges, Tangelos and Tangerines) — use 11/2 pounds per 100 gallons spray solution in Petal Fall or Post Bloom application for the control of Scab and for Melanose For dormant application for the control of Scab use 3 lbs per each 100 gallons spray.
