DIRECTIONS FOR USE

For best results premix with a small amount of water and thoroughly agitate before adding to sprayer tank. Rinse empty container with water and drain into spray tank. Repeat twice more.

USE IN POWER-OPERATED GROUND SPRAYERS.—Use specified dosage of the spray concentrate in 5-10 gallons of water (low volume) to 50-100 gallons (high volume) per acre.

USE IN AERIAL APPLICATION—Use specified dosage of the spray concentrate in 3-10 gallons of water per acre.

RECOMMENDATIONS FOR USE ON COTTON

Cotton fleahoppers, thrips, cotton leafworms, boll weevils: Larly Season Control—use 1/2 pint per acre; make 2 to 4 applications at 7 to 10 day intervals. For Mid and Late Season Control, use 1/2 pint at 4 to 5 day intervals until control is gained.

Aphids, red spider mites: For Early Infestations—use 1 pint per acre at 7 to 10 day intervals, increasing applications to 4 to 5 day intervals if necessary to maintain Mid and Late Season control.

Bollworms: Early Season Control—apply 1 quart per acre at 7 to 10 day intervals. For Mid and Late Season Control, apply 1 quart per acre at 4 to 5 day intervals as required to give control.

After first aid is given (see First Aid Treatment Section) and if a doctor cannot come, take victim to clinic or hospital.

IMPORTANT! Before removing gloves, wash them with soap and water. Always wash hands, face and arms with soap and water before smoking, eating or drinking.

AFTER WORK take off all work clothes and shoes. Shower, using soap and water. Wear only clean clothes when leaving job. Do not wear contaminated clothing. Wash protective clothing and protective equipment with soap and water after each use. Respirator should be cleaned and filter replaced according to instructions included with respirator.

Parathion is a very dangerous poison it rapidly enters the body on contact with all skin surfaces and eyes. Clothing wet with this material must be removed immediately. Exposed persons must receive prompt medical treatment or they may die.

Some of the signs and symptoms of poisoning are: Headache, nausea, vomiting, cramps, weakness, blurred vision, pinpoint pupils, tightness in chest, labored breathing nervousness, sweating, watering of eyes, drooling or frothing of mouth and nose, muscle spasms and coma

Call a doctor (physician), clinic or hospital immediately. Explain that the victim has been exposed to parathion and describe his condition.

If breathing has stopped, start artificial respiration immediately and maintain until doctor sees victim

If swallowed and victim is awake (conscious) make him vomit quickly Induce vomiting by sticking finger down throat or by giving soapy or strong salty water to drink Repeat until vomit is clear. Never give anything by mouth to an unconscious person. Have victim lie down and keep quiet. See doctor immediately.

In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. See doctor immediately.

Antidote---administer atropine sulfate in large doses, TWO to FOUR mg_intravenously or intramuscularly as soon as cyanosis is overcome. Repeat at 5 to 20 minutes intervals until signs of atropinization appear. 2-PAM chloride is also antidotal and may be administered in conjunction with atropine DO NOT GIVE MORPHINE OR TRANQUILIZERS. Para thion is a strong cholinesterase inhibitor affecting the central and peripheral nerv ous systems and producing cardiac and respiratory depression. At first sign of pulmonary edema, the patient should be given supplemental oxygen and treated symptomatically. Continued absorption of the poison may occur and fatal relapses have been reported after initial improvement; VERY CLOSE SUPERVI-SION OF THE PATIENT IS INDICATED FOR AT LEAST 48 HOURS

Toxaphene produces central nervous system excitation which ordinarily responds to the barbituric acid derivatives, but this drug should be given only if complete atropinization fails to relieve symptoms.
