## CAUTION

### DIRECTIONS FOR USE

Start filling tank with water. Sift in required amount of Zineb 75 Wettable when agitator paddles are covered or the jet or recirculating pipe from the pump is covered. Fill tank with water when Zineb 75 Wettable is thoroughly mixed. Spray all foliage thoroughly.

**CITRUS (Florida):** (Grapefruit, Lemons, Limes, Oranges, Tangelos and Tangerines) --- *Greasy Spot Control* - use 1 lb. per 100 gallons of water. Make two applications at 4 - 3 week intervals during July and August.

**NOTE:** Zineb is ineffective against greasy spot in the Indian River area.

Do not re-use container. Destroy by burying in a safe place away from water supplies.
