#### **DIRECTIONS FOR USE**

**IMPORTANT**: Do not expose children, pets, or nontarget animals to rodenticides. To help to prevent accidents:

- 2. Apply bait in locations out of reach of children, pets, domestic animals and nontarget wildlife, or in tamper-resistant bait stations. **MICE**: Apply 1 to 2 Place Pacs at 8 to 12 foot intervals. Larger placements (up to 3 Place Pacs) may be needed at points of very high mouse activity. Maintain an uninterrupted supply of fresh bait for at least 15 days.

Replace contaminated or spoiled bait immediately. Collect and dispose of all dead, exposed animals and leftover bait. To prevent reinfestation, limit sources of rodent food, water, and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations and replenish as needed.
