Directions

Shake container. Hold upright about 2 feet from object to be sprayed. Spray insects directly where possible.

Household insects

Flies, Mosquitoes, Gnats, Moths, Wasps. Close doors and windows of rooms. Spray entire room with sweeping circular motion (5-10 seconds for average room) keeping about 3 feet from walls, furniture, fabrics. Keep room closed for 15 minutes after spraying.

Roaches, Ants, Silverfish, Other Crawling Insects. Spray directly on insects where possible. Spray insect hiding places—under sinks, stoves, in cracks, around doorsills, pipes, windows, storage and refuse areas. Ants—Spray ant trails. Bedbugs—Spray mattresses and beds. Fleas—Spray floor coverings, baseboards, upholstered furniture and sleeping quarters and bedding of animal pets.

Clothes, Moths, Carpet Beetles. Clean woollens thoroughly before spraying. Spray garments completely from a distance of 2 feet, particularly folds and seams. Spray monthly unless garments are stored in a moth-proof container. **For complete protection, spray inside closets and trunks.**

Garden insects

Japanese Beetle, Cucumber Cutworms, Spider Mites, Plant Lice, Thrips, Leaf Hoppers, Spotted Mites, Lace Bugs, Crickets. Hold can 1½ feet from foliage. Spray on insects with one-second bursts using sweeping motion. Spray plant foliage lightly. Never wet heavily. Spray new growths and young plants carefully. Avoid using in direct sunlight or when the temperature is 90° or more. Repeat when necessary. May also be used on indoor house plants.

As outdoor spray

For flies, mosquitoes and small flying insects, spray light mist when air is still. Spray outdoor furniture, picnic tables.

Caution: Contents under pressure. Do not puncture or incinerate can. Do not store above 120°. Do not use near heat or open flame.

Active ingredients: Pyrethrins 0.25%, N-Octyl Bicycloheptene Dicarboximide 0.50%, Technical Piperonyl Butoxide* 0.90%, Petroleum Distillates 4.00%.

Inert ingredients: 94.35%

*Equivalent to 0.72% (butylparthyl) (6-propylpiperonyl) ether and 0.18% related compounds.

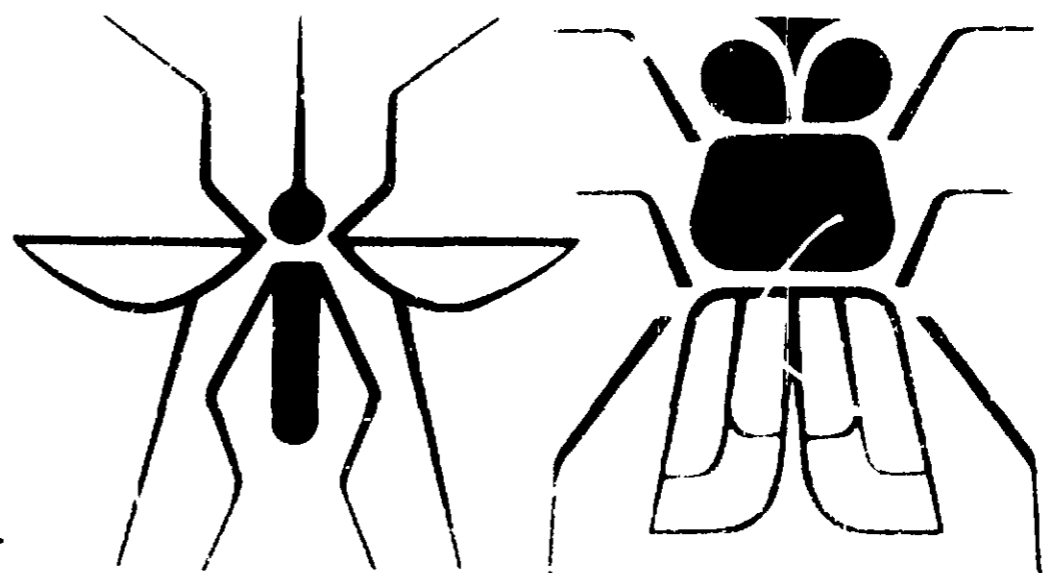
