# d-CON PYRETHRUM outdoor fogger

Improved spray for better outdoor insect control... for greater comfort when you enjoy the patio, yard, open porch or picnic area. You kill flying insects up to 20 feet away. Makes bugs stay away because it both kills and repels.

#### Directions for use—Shake before use

Point valve opening away from face and angled slightly downward. For best results, use when air is calm or breeze is slight.

**For flying insects:** Flies (including DDT-resistant strains), Mosquitoes, Gnats, Hornets, Wasps, Flying Moths. Spray with the breeze and allow fog to drift over area to be protected. When treating grass or bushes stand at least 4 to 6 feet away and drift spray on area to be protected. Repeat as necessary.

**For crawling insects:** Ants, Crickets, Centipedes. Spray infested surfaces of patio or picnic area, hitting as many insects as possible. Spray legs of tables and chairs to repel crawling insects. Spray ant hills and trails thoroughly for best control.

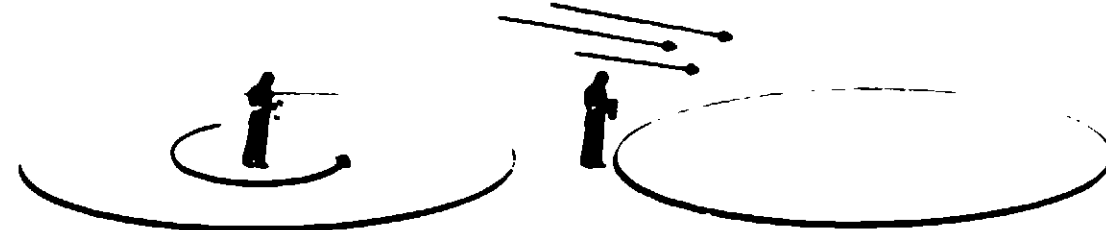

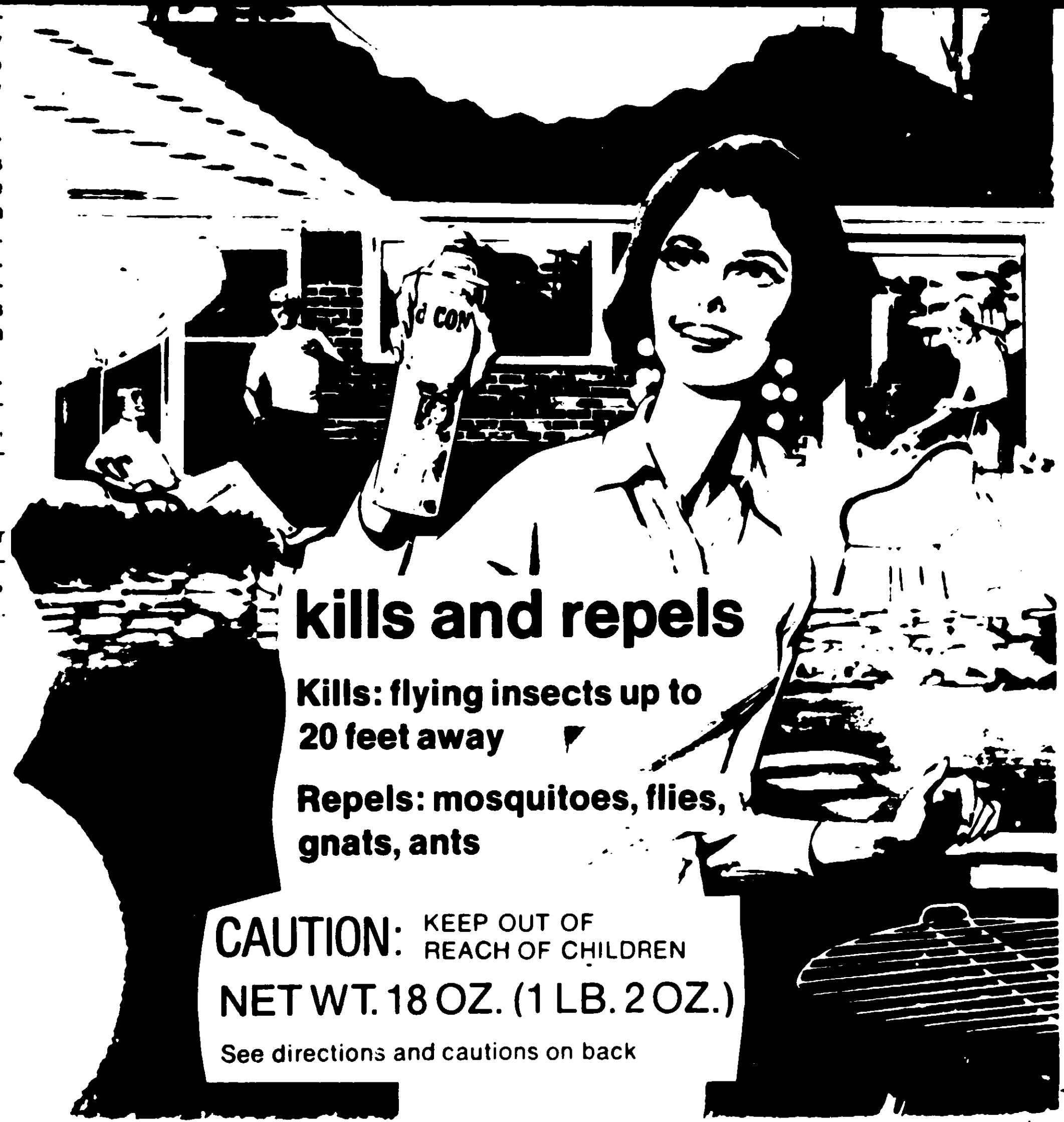
