DIRECTIONS FOR USE:

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. Shake before using. Hold container upright. Apply in short bursts.

INDOORS: For Flies, Mosquitoes, Gnats, Flying Noths: close doors and windows. Cover or remove exposed food, utensils. Remove pets, birds and cover fizh aquariums before spraying. Direct spray upward into center of room with slow sweeping motion. Spray 5-10 seconds for average room. Keep nozzle 3 feet from surface. Keep room closed 15 minutes. Do not remain in treated areas. Ventilate the area after the attention of the surface of the sur

To Kill Roaches and Waterbugs: spray baseboards, cracks crevices, moist areas, openings around sinks, pipes, behind cabinets, where roaches hide.

For Ants: spray ant hills liberally. Spray ant trails around window frames, door sills, other locations.

For house plants: spray short bursts, holding can 18 inches from foliate for English Ivy and African Violets. Spray both sides of leaves lightly. Do not wet. Kills Aphids (plant lice), Spider Mites, Exposed Thrips, Lace Bugs.

OUTDOORS: For insects on Asters, Azaleas, Begonias, Chrysanthemums, Dahilas, Delphiniums, Gladioli, Irises, Marigolds, Petunias, Roses, Snapdragons. Also, for insects specified below on Evergreens and Small Deciduous Trees, Shrubs, Vines.

Sprayed directly on insects, kills sucking insects: Aphids, Leafhoppers, Spotted Mites, Thrips (exposed), Lace Bugs, Chewing insects: Army Worm Larvae, Mexican Bean Beetles, Climbing Cutworms, Japanese Beetles.

For best results spray in evening or on cloudy day when air is still. Use slow sweeping motion. Keep can 18 ounces from plants. Avoid wetting foliage with spray. Spray at rate of 1 foot per second. For heavy growth, spray row on both sides. Spray with caution on new growth. Do not spray when temperatures exceed 90°F. May be used outside to kill Flies, Mosquitoes, Gnats, other small flying insects. Fog area liberally. Spray with breeze allowing fog to drift into shrubbery.



HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION: Harmful if swallowed or absorbed through skin. Avoid breathing vapors. Avoid contact with skin and eyes. Do not use in commercial food processing, preparation, storage or serving areas. In the home, all food processing surfaces and utensils should be covered during treatment or thoroughly washed before use. Cover exposed food. Remove pets, birds, and cover fish aquariums before spraying.

STATEMENT OF PRACTICAL TREATMENT

'IF IN EYES, IMMEDIATELY flush eyes thoroughly with water, remove any contact lens, and continue to flush eyes with plenty of water for at least 15 minutes.

IF ON SKIN wash with soap and water.

PHYSICAL HAZARDS: Contents under pressure. Do not puncture. Do not use or store near heat or open flame. Exposures to temperatures above 130F may cause bursting. Never throw container into fire or incinerator. May stain finished surfaces if sprayed too closely.

ENVIRONMENTAL HAZARD: This pesticide is highly toxic to fish. Do not apply directly to water or wetlands (swamps, bogs, marshes, and potholes). Drift from treated areas may be hazardous to organisms in adjacent aquatic sites. Do not contaminate water when disposing of equipment washwaters.

STORAGE AND DISPOSAL: Storage: Store in original container in areas inaccessible to small children. Disposal: Replace cap and discard in trash. Do not puncture or incinerate.
