Subject: 6/12 Super Strength Premium Insect Repellent

Your Application Dated July 2, 1990

The proposed amendment to the registration of the product cited above under the Federal Insecticide, Fungicide, and Rodenticide Act removing the active ingredient, MGK R-11, and increasing the percentage of another active ingredient is acceptable subject to the comments listed below. A stamped copy of the label is enclosed for your records.

1. Submit the product-specific product chemistry and the data matrix for this new formulation.
2. The statement "Keep Out Of Reach of Children" must appear directly above the signal word "Caution."
3. Provide the flashpoint of the product with the propellant or change the physical and chemical precautions by adding the phrase "Extremely Flammable."
4. The storage and disposal statement must appear under a separate "Storage and Disposal" heading.
5. Add the statement "Do not puncture or incinerate" to the storage and disposal statement.
6. Add the footnote "Contains petroleum distillates" to the ingredient statement.

7. The precautionary labeling section must be changed to read:

Harmful if swallowed. May cause eye irritation. Avoid contact with eyes, lips or open cuts. Do not expose treated skin or clothing to fire, sparks or flame until liquid has evaporated. Do not allow children to rub eyes if hands have been treated.

8. Add a Statement of Practical Treatment to read:

STATEMENT OF PRACTICAL TREATMENT

If Swallowed: Call a physician or Poison Control Center.

If On Skin: May cause skin reactions in rare cases. If so, wash thoroughly with soap and water. Get medical attention if irritation persists.

If In Eyes: Flush with plenty of water. Get medical attention if irritation persists.

9. Submit a 1-year storage stability study. The formulated product must be analyzed for its active ingredients at time zero and during a year in storage. The storage must be under warehouse conditions of temperature and humidity using containers similar to those that will be used in the trade. This data must be submitted within 15 months of the date of this letter.

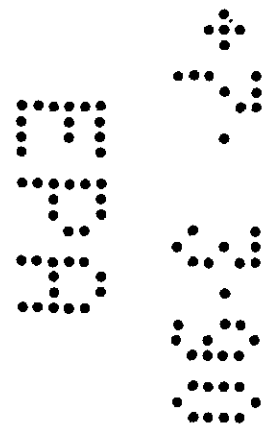
