3. Delete the statement "This product contains the toxic inert ingredient Methylene Chloride." The product no longer contains Methylene Chloride.

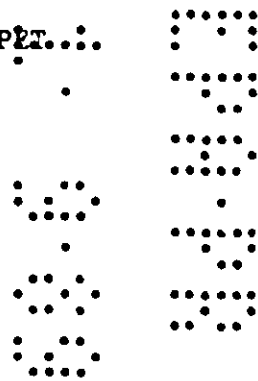

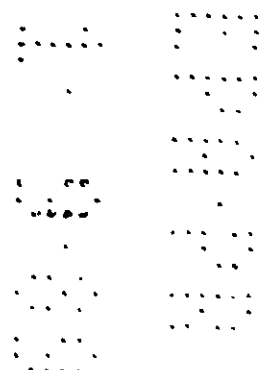

PREPARATION

COVER asphalt tile, waxed wood floors and waxed furniture which may come in contact with the fog (newspapers may be used).

OPEN cupboards, closets, trunks and interior doors in area to be treated.

REMOVE pets and cover or remove fish tanks and bowls; remove or cover foods, dishes, utensils, food handling equipment and articles made of cotton terrycloth.

CLOSE outside doors and windows; turn off fans and air conditioners.

EXTINGUISH all open flames except pilot lights.

DIRECTIONS

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

1. Set can near the middle of the room on a raised spot such as a table or chair, BUT at least six feet from pilot light. Spread several sheets of paper under can to cover area directly beneath container. Remove cap.

2. Tilt top of can AWAY from face.

3. Press lever down firmly until it clicks.

4. Set can upright on paper...

5.and leave the room closing the door behind you.

6. Keep room being treated closed. Do not re-enter room for 4 hours.

7. After 4 hours, open all doors and windows, turn on air conditioners and fans. Before reoccupying, let the treated area air for 30 minutes. Repeat treatment in two weeks or as necessary.

**PRECAUTIONARY STATEMENTS
HAZARDS TO HUMANS AND DOMESTIC ANIMALS**

CAUTION: Harmful if swallowed. Avoid inhalation of vapors. Avoid contact with skin, eyes or clothing. Avoid contamination of food and feedstuffs. Exposure to temperatures above 130°F may cause bursting.
