Remove and destroy pet's old bedding. Spray sleeping quarters of pets around baseboards, window and door frames, wall cracks and local area of floor. Repeat as necessary. Do not spray animals. Put fresh bedding on pet's quarters after spray has dried. Also treat dogs and cats with a registered tick control product before allowing them to enter treated areas.
