Purpose

The purpose of your submission under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA) is A) to add two additional package sizes: 1) 4, 1 oz place packs and 2) 5, 1 oz place packs and B) to add two claims to your label.

A. Packaging

The 1.0-oz placepacks would not provide enough bait for a single placement at the labeled rate for controlling commensal rats. Therefore, it would be illegal to sell such placepacks individually (or in groups of less than 4) if rat directions appeared on the labeling.

B. Label

The label submitted with the above letter, under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA) is acceptable, provided that you make the following changes and submit one (1) copy of final printed labeling, including graphics, to us before you release product for shipment. A copy of the stamped label is enclosed for your records.

1. The only "Graphic - Rodent" that may appear is the one accepted in our January 26, 2003, letter. For mouse-only presentations, you may only use a house mouse graphic.

## B. Labelcontinued

- 2. The proposed claims, "Mice (will) eat through (the) (place) (pack) pack." and "Ready-to-use place packs" are acceptable. The "Mice(& Rats)" version of the first of these claims may only be used on packages that bear claims for controlling commensal rats as well as house mice.
- 3. Packages of 4-14 of the 1-oz placepacks would have to bear appropriate qualifying statements advising customers and users of the limited numbers of rats that could be expected to be killed with the amounts of bait provided in such packages. At present, you are not marketing such packaging combinations, based upon our information.
- 4. Replace "Toxicity Category I Pesticide" with "Have label with you when seeking treatment advice."

Existing stocks

Stocks of existing labels may be used for eighteen (18) months.

Consequence for non-compliance

If these conditions are not complied with, the registrations will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.



Generally, these are along walls, by gnawed openings, in or beside burrows, in corners and concealed places, between floors and walls, or in locations where rodents or signs of rodents have been seen. Remove as much alternative food as possible. Use tamper-resistant bait stations wherever necessary (see "IMPORTANT:").


## APPLICATION DIRECTIONS:

To Control Norway and Roof Rats: Use 4-16 bait packs per placement. Space placements at intervals of 15-30 feet in infested areas. Maintain an uninterrupted supply of fresh bait for at least 10 days.

To Control House Mice: Use one bait pack per placement. Space placements at intervals of 8 to 12 feet in infested areas. Up to 2 bait packs may be used at points of very high mouse activity. Maintain an uninterrupted supply of fresh bait for at least 15 days.

For Rats and Mice: Check bait locations every 2 days for signs of feeding. Replenish bait if more than 1/2 of the original amount has been removed by rodents. If bait packs are not opened by rodents for 5 consecutive days, they may be relocated to other places where rodent activity exists and where bait placements consistent with the requirements of this label can be made.

Collect and dispose of all dead animals and leftover bait properly. To discourage reinfestation, limit sources of rodent food, water and harborage as much as possible. If reinfestation does occur, establish permanent bait stations and replenish as needed.
