The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance.

This bait station may be used in indoor areas accessible to children, consistent with all use restrictions and other requirements indicated in this label. **DO NOT USE THIS PRODUCT OUTDOORS OR IN AREAS ACCESSIBLE TO PETS.** 

Only for control of Norway rats, roof rats and [and house mice] inside of homes. d-CON® [KILLS RATS]/[KILLS RATS AND MICE] bait station must be used in homes consistent with all use restrictions and other requirements indicated on this label. Do not place this bait station in any area where there is a possibility of contaminating food or surfaces that come into direct contact with food.

**Selection of treatment areas:** Determine areas where rats [or house mice] will most likely consume the bait. Generally these are along walls by gnawed openings, in corners and concealed places.

### To control Norway Rats [,/and] Roof Rats [and house mice]

- 1. Remove the bait station from the carton/bag
- 2. Placement: Place along walls or in corners with the entrance holes exposed.

While wearing gloves, place 1 or 2 blocks on each peg/rod in the bait station. [Station can hold up to 6 bait blocks]. Replace each block as necessary. Place the bait station indoors at the highest point of activity, by gnawed openings, in concealed areas along a wall or in corners in areas inaccessible to pets where rats [and/or house mice] or their signs have been seen. Place additional bait stations at 15 to 30 foot intervals. Maintain a constant supply of fresh bait for at least 15 days or until signs of rat [or mouse] activity cease infested areas. While wearing gloves, replace bait in bait station when bait is consumed or contaminated. If bait is not touched after 3 days, move station to a new location where rat [and/or mouse] activity is evident.

**Follow-up:** Wearing gloves, collect and dispose of all dead animals and emptied bait stations properly as specified on this label. To discourage re-infestation, limit sources of rodent food, water and harborage as much as possible. If re-infestation does occur, repeat treatment.

### To [Load or] Refill {Pictograms made added to illustrate each step}

You will need both hands to open the station.

- 1. Locate the 4 latches on top of the station
- 2. With the thumb of one hand, push down on the outer latch while simultaneously squeezing the other latches and pulling lid up wards with the other hand.
- 3. Wearing gloves, fill the station by placing up to 6 blocks on the rods/pegs.
- 4. Close the station by firmly pushing the window down until latches click into place. The bait station is securely closed when all 4 latches have snapped back in to place
- 5. Remove and dispose of gloves. Then wash hands thoroughly.

Do not contaminate water, food or feed by storage or disposal.


Optional pictogram of front panel graphic




