

CHLORDANE 10% DUST

DIRECTIONS FOR USE

Use only for claims listed in accordance with all label directions.

Chlordane 10% Dust is recommended for Fire Ants and Japanese beetle larvae control.

OBSERVE THESE RULES:

Clear up spills on walks or patios by hosing area. Store in a special cabinet away from children. Toxic to fish and wildlife. Do not contaminate any body of water. Do not use where run-off is a frequent problem.

Birds feeding on treated areas may be killed. To protect bees and other pollinators, apply in early morning or late evening.

This product is toxic to fish and wildlife. Keep out of lakes, streams or ponds. Do not apply when weather conditions favor drift from area treated. Do not apply where runoff is likely to occur. Do not contaminate water by cleaning of equipment, or disposal of wastes. Apply this product only as specified on this label.

ANTIDOTE

EXTERNAL — In case of spillage on skin, wash promptly with soap and water.

INTERNAL — Emetic of 1 tablespoonsful mustard in tumbler of water. Call a physician.

CAUTION

Harmful if swallowed. Contact with skin can cause toxic symptoms. Avoid breathing dust. In case of contact with skin, wash with soap and water. Avoid contamination of feed and foodstuffs. Keep out of the reach of children. Keep children or pets off treated ornamental turf until material has been washed into the soil by watering or rain and grass is dry.

CONTAINER DISPOSAL

Do not reuse empty container.

Rinse equipment and containers and dispose of wastes by burying in non-crop lands away from water supplies. Containers should be disposed of by punching holes in them and burying with wastes, or by burning. Keep out of smoke.
