**APPLICATION RATE**


FOR the control of Cabbage Looper on Broccoli, Cabbage, Cauliflower, Collards, Celery, Lettuce, Melons, Potatoes, Spinach, Tomatoes and Cucumbers, apply 25 to 50 lbs. per acre. GROUND APPLICATION ONLY: Cabbage Looper on Kale, Mustard Greens and Turnip Greens apply at 25 to 50 pounds per acre.

FOR the control of Imported Cabbage Worm on Broccoli, Cabbage, Cauliflower, Collards and Turnip Greens, apply 15 to 25 lbs. per acre.

GROUND APPLICATION ONLY: Imported Cabbageworm on Kale and Mustard Greens apply at 15 to 25 pounds per acre.

FOR the control of Hornworm on Tobacco, apply 12 to 25 lbs. per acre.
