Spray infected surfaces only until wet.

ROACHES, ANTS, WATERBUGS, SILVERFISH, SPIDERS, CRICKETS: Spray heavily in all cracks, around baseboards and other places where these insects hide. Also spray until wet, surfaces behind and beneath caulinets, refrigerators, sinks, stoves. Use on other localized areas infested with these pests. Repeat treatment as required.

CARPET BEETLES: Make localized application to areas of the floor and baseboards. Spray directly into cracks and under carpets where insects may be found. Treat crevices, cracks or closets and infested areas of shelvings. Repeat as necessary. FLIES, MOSQUITOES, WASPS, AND FLYING MOTHS OUTDOORS: For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, window frames or wherever these insects may enter the room. Also treat surfaces around light fixtures on porches, in garages, and other places where these insects alight or congregate.

FLEAS, CHIGGERS and ANTS: Outdoors: For treatment of localized infestations of these insects in outdoor areas where there is no vegetation, spray infested areas thoroughly. For Ants, thoroughly wet hills and funways. Repeat applications as infestations warrant and as reinfestations occur.

ODORLESS, STAINLESS, KILLS EVEN RESISTANT ROACHES, RE-SIDUAL TYPE. CAUTION:

Harmful if swallowed. Keep out of reach of children.
Avoid contamination of feed and foodstuffs. Do not use in edible products areas of food processing plants.
