a) Because this product is intended for both commercial agricultural use and residential (non-agricultural) use, please change the heading of the USER SAFETY REQUIREMENTS box to read "RESIDENTIAL USER SAFETY REQUIREMENTS" in order to avoid confusion with the requirements of the Worker Protection Standard.

2. Submit one copy of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions. A stamped copy of the labeling is enclosed for your records.

AGRICULTURAL USE REQUIREMENTS

Use this product only in accordance with its tabeling and with the Worker Protection Starkiard. 40 CFR part 170. This Standard contains requirements for the protection of agricultural workers on tarms, forests, nurseries, and greenhouses, and handlers of agricultural positivities. It contains requirements for the protection starkiard, and emergency assistance. It also contains specific instructions and exceptions pertaining to the statements on this tabel about personal protective equipment (PPE), and restricted-entry interval. The requirements in this box only apply to uses of this product that are covered by the Worker Protection Standard. Do not enter or allow worker entry into treated areas during the assistence of 12 hours.

Wearing household latex or rubber gloves, use a dust applicator such as a shaker can, dust gun, puffer or other bulbous duster, rotary duster or other appropriate duster as available. Dust lightly to cover both upper and lower leaf surfaces with a thin, even film of dust. Apply when air is calm to avoid drift and contact with eyes and skin. Start applying at the farthest corner of the treatment area and work backward to avoid contact with dusted surfaces. Allow dust to settle in treated areas before reentering.

For plants above chest height, consider using a liquid carbaryl product, Do not repeat application more than once a week.

BEANS: To control Mexican Bean Beetle apply at the rate of 25 to 30 ppunds per acre of 2 ounces per 50 feet of row, Make the first application when Insects or egg masses on the underside of the leaves are first seen. Thorough application to the lower as well as the upper leaf surface is necessary for good results. Repeat applications at 7 to 10 day intervals as necessary for control.
