Use contrary to these directions may result in excessive Malathion residues, in unsatisfactory control or in other unintended consequences.

STORED GRAINS: (Corn, Wheat, Rice, Rye, Barley, Grain Sorghum, Field or Garden Seeds — Against Rice Weevil, Indian Meal Moth, Confused Flour Beetle, Granary Weevil, Saw-Toothed Grain Beetle, Flat Grain Beetle, and Red Flour Beetle. Use at the rate of 60 Lbs. per 1,000 bushels (6 Lbs. per 100 bushels). Mix thoroughly and evenly as the grain or seed is being loaded or turned into storage.

INDIAN MEAL MOTH — To protect stored grain apply evenly to the surface of clean or uninfested grain at the rate of 30 Lbs. per 1000 Sq. Ft. of grain surface area. (3 Lbs. per 100 Sq. Ft.) Apply immediately after loading into storage. Repeat if necessary.
