The amendment, referenced above, submitted in connection with registration under FIFRA sec. 3(c)(7)(A) to update the labeling is acceptable provided the following recommendations are addressed before this product is released for shipment.

### Acute Toxicology

The acute toxicology studies submitted 4/24/00 for 3377-45 will also support BQ 451-5 Biocide (3377-31) and BQ 451-5 WW Biocide (3377-47). Since all three products contain the same active ingredient only differing by concentration, the data conducted on 3377-45 will be bridged to support 3377-31 and 3377-47.

### Acute Toxicology Profile:

acute dermal by stating "May be fatal if swallowed, absorbed through the skin, or inhaled."

Under Once Through Fresh Water Cooling System, the dilution rate, 1.5 fl. oz per 1000 gallons of water does not equal 10 ppm product but 12 ppm. You will need to revise the range accordingly.

## DIRECTIONS FOR USE:

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.  
Do not use water containing residue from use of this product to irrigate crops used for food or feed. Use of the product in either public/municipal or single or multiple family private/residential potable/drinking water systems is strictly prohibited. Use of this product in any cooling water system that discharges effluent within 1/4 mile of either a public/municipal or single or multiple family private/residential potable/drinking water intake is strictly prohibited.

## INITIAL APPLICATION FOR INDUSTRIAL AND/OR COMMERCIAL RECIRCULATING COOLING WATER TOWERS

### (To a clean system)

The dose should be poured into the sump of a system which is clean or in which growth is first noticed.

5.25 to 10.25 fluid ounces (20 to 40 ppm on an active quaternary basis) per 1000 gallons of contained water. When heavy algae growth is present, system will have to be cleaned manually.

### SUBSEQUENT APPLICATION

1.33 to 3.85 fluid ounces (5 to 15 ppm on an active quaternary basis) per 1000 gallons of contained water.

The above directions should be followed twice weekly or as needed. If algae growth is noticeable, apply the initial dose.

### ONCE THROUGH FRESH WATER COOLING SYSTEM

For control of Algae and Algae Slime Growth

1. Wear safety glasses, rubber gloves and impervious apron.
2. Add product directly from drum or add the product at a point where it will be mixed uniformly.
