2. Efficacy

Even though, Methicillin Resistant *Staphylococcus aureus* and Penicillin Resistant *Streptococcus pneumoniae* are standard ATCC cultures, you still need to submit additional information proving these strains of bacteria are antibiotic resistant. The Agency recommends using the standard sensitivity testing method. The organisms, Methicillin Resistant *Staphylococcus aureus* (MRSA) ATCC 33591 and Penicillin Resistant *Streptococcus pneumoniae* ATCC 35088, must be deleted from the label.

DIRECTIONS FOR USE :

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

This product is not to be used as terminal sterilant / high level disinfectant on any surface or instrument that (1) is introduced directly into the human body, either into or in contact with the bloodstream or normally sterile areas of the body, or (2) contacts intact mucous membranes but which does not ordinarily penetrate the blood barrier or otherwise enter normally sterile areas of

the body. This product may be used to pre-clean or decontaminate critical or semi-critical medical devices prior to sterilization or high level disinfection.

CLEANING/DEODORIZING

Add use solution (1:64 dilution) to hard, nonporous surfaces, thoroughly wetting surfaces with a cloth, mop, sponge, or sprayer. Allow surfaces to air dry.

MOLD AND MILDEW / FUNGISTAT CONTROL: At a 1:32 solution, **ACLD - 64** will effectively inhibit the growth of mold and mildew and the odors caused by them when applied to hard, nonporous surfaces. Follow disinfection instructions. Allow to dry on surface. Repeat when mildew growth returns.

Kills Trichophyton metagrophytes, the fungus causing athlete's foot, on environmental surfaces such as shower room floors, locker room benches, and bath mats.

GENERAL DISINFECTION

For use on the following hard, inanimate, non-porous surfaces: floors, walls, metal surfaces, glazed porcelain, and plastic surfaces. PERSONAL PROTECTION: Disposable latex or vinyl gloves, gowns, face masks or eye coverings as appropriate, must be worn during all cleaning of blood/body fluids, and decontamination procedures.

CLEANING PROCEDURE: Blood / body fluids must be thoroughly cleaned from surfaces and objects before application of the disinfectant.
