

LIMITATIONS

- Apply in spring before temperatures reach 70-75° for 3 consecutive days.
- Do not reseed for at least 6 weeks after application.
- Do not apply the spring following a fall seeding.
- Do not apply to bentgrass putting greens.
- Apply accurately and uniformly.
- Regular fertilizing with Golf Brand Lawnfood thickens turf, crowds out weeds.
- Renew thin turf by interseeding with Golf Brand Lawn Seed after the six week precautionary period has ended.
