Thereafter follow up with maintenance dose of 32 fluid oz, per 12,500 gallons pool water every 5 to 7 days or as needed. Add this product to pool water in front of the pool return while filter is on, for best results allow filter to run for at least 24 hours after adding this product. This product is effective over all normal pool balance values. Bathers should not be in the pool when this product is added and should not re-enter for at least 15 minutes. The above directions should be followed even when the pool is not in use. Do not use water containing residue from this product to irricate crops used for food or feed. 18-19 20 21 use water containing residue from this product to irrigate crops used for food or feed.
