The proposed amendment concerning a change in the use directions of the subject product labeling and a change in product name have been reviewed. Please note the following.

The proposed change in product name from "Premium Liquid Algaecide" to "Winter Alagaecide" is acceptable and has been recorded in your product file.

The proposed change in use directions on the product label for the use of the product as a winter algaecide is acceptable.

The revised labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. A stamped copy is enclosed for your records. Five copies of the finished labeling, which incorporates these comments must be submitted before releasing the product for shipment.

1. Revise the product description sentence ("A specially prepared fluid...") to read: "A specially prepared fluid to help keep pool water algae free during the winter months". The term "fresh" is an implied safety term and is not allowed.

2. On the front/center panel, place the signal word "CAUTION" immediately below "Keep Out Of Reach Of Children".

3. In the front panel referral statement, change the word "cautions" to "precautions".

4. Submit a revised Confidential Statement of Formula (CSF) which lists the EPA Registration No. of your source product in column 12. In column 13 list the amounts of the ingredients used in a batch sized formulation of your product. (A blank CSF form is enclosed.)

**PRECAUTIONARY STATEMENT

**DIRECTIONS FOR USE**

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

This product will prevent growth of most algae during the off-season winter months when pools are not in use. For pools which have been properly treated during the swimming season and are free of visible algae, add 40-64 fl. oz. of algaecide per 10,000 gals. of water. If at the end of swimming season, pools have some visible algae growth, add 74-112 fl. ozs. per 10,000 gals. It is necessary that a uniform distribution of algaecide throughout the water and the pool be made for maximum effectiveness. If pool is not covered, it may be necessary to repeat the treatment one or more times during the season.
