As Agent for N. Jonas & Company Inc. ("Jonas"), I am submitting a Notification under the provisions of PR Notices 1998-10, 2007-1 and 2007-4 to advise the Agency of minor changes to the label for **Quick Shock (EPA Reg. No. 3432-66)**.

The label changes are as follows:

- 1) Replace the Environmental Hazards language, which was inadvertently omitted from the last label notification.
- 2) Update the container disposal language in the Storage and Disposal section per the instructions provided in PR Notice 2007-1 and PR Notice 2007-4. Please note that this Jonas product is sold for household/residential use only. Therefore, only the label language for household/residential containers required by these PR Notices is applicable to this product.
- 3) Add various optional marketing statements to the front panel of the label.

This same label was recently reviewed in conjunction with the January 26, 2009 Notification submission. The only difference is that we have removed the marketing statement, "Kills Bacteria" in accordance with the March 10, 2009 EPA letter (copy attached). We hope, therefore, that the enclosed Notification submission can be reviewed as expeditiously as possible.

- 1) Pesticide Application Form; and,
- 2) Three (3) copies of the revised product label with the changes highlighted.

Before treating the pool, it should be chemically balanced. The pH should be adjusted to 7.4-7.6. The alkalinity and calcium hardness should also be measured to insure that they are in proper range. For WHITE PLASTER POOLS ONLY, broadcast the product directly into the pool water. Pre-dissolve the recommended dose of this product for all other pools, VINYL, FIBERGLASS, PAINTED AND ALL COLORED PLASTER POOLS. To pre-dissolve, add one pound of QUICK SHOCK CHLORINATOR to 2-3 gallons of water in a clean bucket. REMEMBER that the shock should be added to the water. NEVER add water to dry product. Use 1 to 2 pounds to treat each 10,000 gallons of water. Do not mix more than one pound at a time and never add any other chemicals or products to the solution in this bucket.
