



DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Initial Application:

1. While the filter is running, broadcast two pounds of BOR-X per 1,000 gallons over the pool water surface. Divide the initial dose into two half doses and add each half dose to the pool 10 minutes apart. The initial application of BOR-X will raise the pH of the pool, to regulate this pH change add $\frac{3}{4}$ lbs. pH Down (Sodium Bisulfate) for each pound of BOR-X. Dissolve the pH Down in a pail of water, one pound at a time. When fully dissolved add to the pool water.
2. Run the filter for approx. 4 hrs then test the pH. Adjust the pH, if needed, at this time. The pH must be maintained between 7.4 and 7.6. Correct water balance should be maintained, see your dealer for instruction.
3. Once each month test the BOR-X residual. It should be maintained at 30-50 ppm. Your professional dealer can test this for you. Only filter backwashing and splash-out will result in the loss of BOR-X from the water.

WINTERIZATION

BOR-X will also enhance your winterizing program. BOR-X can be used with your regular winterizing kit. Test the BOR-X level to insure that it is at the recommended value. Your professional dealer can test this for you.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage, disposal or cleaning of equipment.

PESTICIDE STORAGE: Store in original container in a locked area, inaccessible to children and pets. Store in a cool, dry well-ventilated area.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

CONTAINER DISPOSAL: Place container in trash collection or dispose in approved landfill area. Do not reuse empty container.
