- 4. Because the compound is a strong oxidizer, you must submit a one-year storage stability study done according to 830.6317 and a study on corrosion characteristics according to 830.6320. You must also clarify the discrepancy in density on the CSF and in the study. The study references a source that say that the loose bulk density is 31 lb/ft³ and that the granular density is 60 lb/ft³; however, the CSF states that the loose bulk density is 63 to 66 lb/ft³. You must also ensure that the pH stated in the study has the same value as that stated on the CSF.
