3. Submit two copies of the revised final printed label for the record.		
4. Because the compound is a strong oxidizer, you must submit a one-year storage stability study done according to 830.6317 and a study on corrosion characteristics according to 830.6320. You must also clarify the discrepancy in density on the CSF and in the study. The study references a source that say that the loose bulk density is 31 lb/ft ³ and that the granular density is 60 lb/ft ³ ; however, the CSF states that the loose bulk density is 63 to 66 lb/ft ³ . You must also ensure that the pH stated in the study has the same value as that stated on the CSF.

PRECAUTIONARY STATEMENTS

DANGER – HAZARD TO HUMANS AND DOMESTIC ANIMALS

ENVIRONMENTAL HAZARD

This pesticide is toxic to fish and aquatic organisms. Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans, or other waters unless in accordance with the requirements of a National Pollutant Discharge Elimination System (NPDES) permit and the permitting authority has been notified in writing prior to discharge. Do not discharge effluent containing this product into sewer systems without previously notifying the sewage treatment plant authority. PHYSICAL OR CHEMICAL HAZARD

Strong oxidizing agent. Contact with water slowly liberates irritating and hazardous chlorine containing gases. Decomposes at temperatures above 437°F (225°) with liberation of harmful gases. When ignited, will burn with the evolution of chlorine and equally toxic gases.

Never add water to product. Always add product to large quantities of water. Use clean, dry utensils. Do not add this product to any dispensing device containing remnants of any other product. Such use may cause a violent reaction leading to fire or explosion. Contamination with moisture, organic material, or other chemicals may start a chemical reaction with generation of heat, liberation of hazardous gases, and possible fire and explosion.

IN CASE OF FIRE OR SMOKE: Call the fire department. Do not attempt to extinguish the fire without a self contained breathing apparatus (SCBA). Do not let the fire burn. Flood with copious amounts of water. Do not use ABC or other dry chemical extinguishers since there is the potential for a violent reaction.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

FOR INDUSTRIAL USE ONLY

This product is intended for repackaging and formulating as a microbiocide/microbiostat, disinfectant, sanitizer, bactericide, fungicide, or algacide into end-use products for the following general use sites: aquatic non-food industrial, aquatic non-food residential, indoor food, indoor non-food, and indoor residential.

Re-packers or formulators using this product are responsible for obtaining EPA registration of their products.

This product may be used by manufacturers of non-pesticidal products provided no pesticidal claim is made.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal

STORAGE: Keep material dry and in a dry area. Store in original container where temperatures do not exceed 125°F (52°C) for 24 hours. Retie polyethylene liner after each use and keep container tightly closed.

PESTICIDE DISPOSAL: Pesticide wastes are toxic. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal Law.
