The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all of the information submitted with your application to support the Registration Review of the above referenced product in connection with the Polixetonium Chloride Interim Decision, and has concluded that your submission is acceptable.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. Pursuant to 40 CFR 156.10(a)(6) you must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 12 months from the date of this letter. After 12 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

CAUTION: Causes moderate eye irritation. Harmful if swallowed or absorbed through skin. Avoid contact with eyes, skin, or clothing. Wear protective eyewear. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco or using the toilet. Remove and wash contaminated clothing before reuse.

Before draining a treated [pool], [spa], [hot tub], or [fountain], contact your local sanitary sewer and storm drain authorities and follow their discharge instructions. DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Users are recommended to wear waterproof or chemical-resistant gloves when applying this product to pools Suggested glove types include Butyl and Nitrile.

ON GUARD WINTER PROTECT ALGAECIDE is used to control the growth of algae in swimming pools, heated swimming pools, exterior spas, whirlpools and hot tubs.

SWIMMING POOLS, HEATED SWIMMING POOLS, EXTERIOR SPAS, WHIRLPOOLS AND HOT TUBS:

For maximum effectiveness of this product in pools, spas, whirlpools and hot tubs, clean those systems with heavy growth of algae prior to using this product. For pools having just visible algae growth, add an initial dose of 50 to 77 fluid ounces of ON GUARD WINTER PROTECT ALGAECIDE per 10,000 gallons of water and remove settled algae debris by cleaning. For treatment of a freshly cleaned and filled pool, add initially 27 to 50 fluid ounces of ON GUARD WINTER PROTECT ALGAECIDE per 10,000 gallons of water. To maintain pools free of visible algae growth, make subsequent additions of 9 to 18 fluid ounces of ON GUARD WINTER PROTECT ALGAECIDE per 10,000 gallons of water every 5 to 7 days after initial treatment. Uniform distribution of this product throughout the water in the pool is necessary for maximum effectiveness. Spas, whirlpools and hot tubs having just visible algae growth require an initial dose of 5 to 8 fluid ounces of this product per 1000 gallons of water. For treatment of a freshly cleaned spa, whirlpool and hot tub, add initially 3 to 5 fluid ounces of this product per 1000 gallons of water. Make subsequent additions of 1 to 2 fluid ounces this product every 5 to 7 days after the initial dose for maintenance.

This product will prevent growth of most algae during the off-season winter months when pools are not in use. For pools which have been properly treated during the swimming season and are free of visible algae, add 27 to 43 fluid ounces of algaecide per 10,000 gallons of water. If, at the end of swimming season, pools have some visible algae growth, add 50 to 77 fluid ounces per 10,000 gallons of water. It is necessary that a uniform distribution of algaecide throughout the water and the pool be made for maximum effectiveness. If the pool is not covered, it may be necessary to repeat the treatment one or more times during the season.

This product is compatible with those chemicals normally used to treat pools and spas and is effective at both acid and alkaline pH. This product can be used in pools and spas treated with chlorine chemicals and may reduce the amount of those chemicals normally required. However, do not mix this product with concentrated dry or liquid chlorine products.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. Do not ship with food, feed, drugs, or clothing.

STORAGE: Keep container closed when not in use. Keep away from children and persons unfamiliar with its use. Store away from food. In case of spills, use sawdust or sand to absorb the spilled pesticide and disposed of in a sanitary landfill. Leaking or damaged containers must be placed in a plastic bag and discarded in the trash. Mop up spills with clean water.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed of on-site or at an approved waste disposal facility.

CONTAINER HANDLING: Nonrefillable container. Do not reuse or refill this container. Triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container ¼ full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for the later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. Then offer for recycling if available or reconditioning, if appropriate, or by other procedures if approved by state and local authorities.
