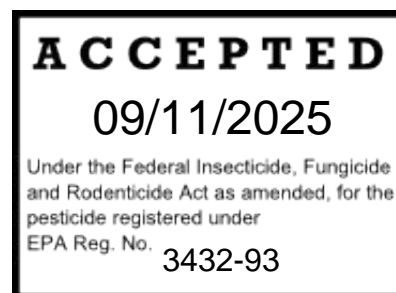

<b>FIRST AID</b>

## **PRECAUTIONARY STATEMENTS**

### **HAZARDS TO HUMANS AND DOMESTIC ANIMALS**

CAUTION. Harmful if swallowed. Causes moderate eye irritation. Avoid contact with skin, eyes, or clothing. Wash thoroughly with soap and water after handling and before eating, drinking, and chewing gum, using tobacco or using the toilet. Remove contaminated clothing and wash before reuse.

## **DIRECTIONS FOR USE**

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

### **DOSAGE RATES**

EVERY THREE MONTHS: 16 fl. oz. of this product per 10,000 gallons of pool water (or 500 ml per 40,000L) will prevent algae from growing in all pool types.

SEVERE ALGAE TREATMENT: 32 fl. oz. of this product per 10,000 gallons of pool water (or 1 L per 40,000 L).

### **GENERAL DIRECTIONS**

1. Maintain pool water in the pH range 7.2 to 7.8. Total alkalinity 80 ppm to 120 ppm. Adjust pH to 7.2 for severe algae.
2. Ensure that filtration system is working properly.
3. Brush pool regularly.
4. Calculate the volume of this product required for the pool.
5. Add the product directly to pool deep end preferably in front of a water return. Dilute in a bucket of pool water when adding to pools with plaster finishes.

This product must be used along with adequate levels of an EPA registered sanitizer (e.g. chlorine) to control bacteria.

Before draining a treated pool, contact your local sanitary sewer and storm drain authorities and follow their discharge instructions. Do not discharge treated pool or spa water to any location that flows to a gutter or storm drain or natural water body unless discharge is allowed by state and local authorities.
