DIRECTIONS FOR USE

Use this product for prevention and control of brown patch, dollar spot, copper spot, red thread (pink patch), and leaf blights, such as caused by Helminthosporium and Curvularia.

UNDER NORMAL WEATHER CONDITIONS, this product is effective in preventing above diseases when applied at 2 oz. per 1,000 sq. ft. every 5 to 7 days.

DURING PERIODS OF HIGH TEMPERATURE AND HUMIDITY, which are favorable for disease development, product may be applied at heavier dosages (4, 6 or even 8 oz. per 1,000 sq. ft.) or more frequently (as often as 3 or 4 times per week) if necessary to keep disease under control, without injury to fine turf grasses.

SPRAY PREPARATION

Fill tank with 5 to 10 gallons of water for each 1,000 sq. ft. of turf to be treated. Add required amount of product and keep in suspension by agitation.

IMPORTANT—Fungicides tend to wash from grass blades during hard rains or under conditions of heavy, daily watering. Watering after application is unnecessary and should preferably be delayed for 24 hours after application, especially at times when diseases may be expected to be severe.
