2. To prevent the growth of Crabgrass, Paspalums, Sedge and Spotted Spurge, apply in January, February or March before these weeds germinate. This product will not control these weeds if they are present in the lawn at the time of application. In newly sprigged lawns, apply soon after planting to reduce competition from weeds. To avoid drift, apply when air is calm.

HOW TO APPLY:

The content of this bag will cover an area of 4,000 square feet (100' X 40') when applied according to directions. If soil is dry, water thoroughly the day before treatment. Treat entire lawn evenly. Do not exceed recommended rate. Immediately after application, water to wash pellets off of the grass blades. Vertagreen Weed and Feed is for use on St. Augustine and Centipede lawns only. Do not use on Bluegrass, Fescue, Bentgrass, Bahia, Rye, Bermuda or Dichondra lawns.

On newly seeded Centipede, wait until the new grass has been mowed at least once before applying. Delay sprig planting one month after application. Avoid application to the root zone of trees and shrubs. This root zone extends from the trunk out to a point under the branch tips. Avoid application on garden plants, flowers, and shrubs.
