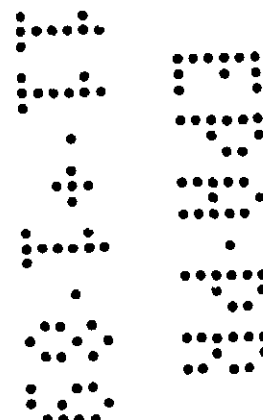

Dosages vary with different equipment, but in general, most effective results are obtained with 1 pint to each 15,000 to 30,000 cubic feet of space. In all cases, the fog or vapor should thoroughly fill the enclosure, and minimum of 0.2 oz. for flying insects, or 1 oz. for crawling insects, should be used per 1,000 cubic feet of space. For crawling insects, direct the fog into cracks, crevices and other infested areas.

FOR USE IN FOOD PROCESSING PLANTS

CAUTION

Although Pyrenone[®] materials can be used around grain, food, food products, utensils, containers and food-handling and processing equipment it should not be applied directly to uncovered food or foodstuffs. Foods should be removed or covered during treatment. All food processing surfaces should be covered during treatment or thoroughly cleaned before using. 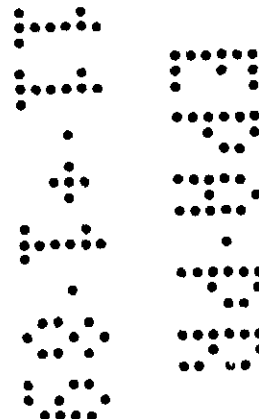
