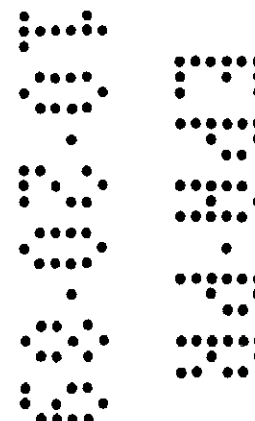

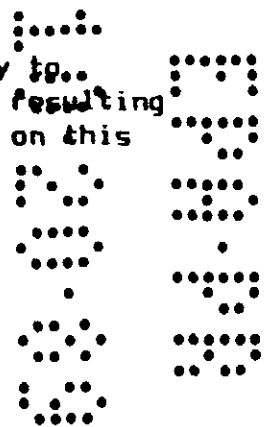

PRODUCT INFORMATION

Use this product to control the pests indicated in the areas listed below by application of this product as undiluted spray (0.5% Chlorpyrifos). Repeat the treatment as needed.

PESTS INDOORS

For Spot Treatment Only - Apply as a coarse spray or with a paint brush to localized areas where cockroaches (including strains resistant to other insecticides), ants, clover mites, crickets, firebrats, silverfish, and spiders are found or normally occur, including dark corners of rooms and closets, cracks and crevices in walls, along and behind baseboards, beneath and behind sinks, stoves, refrigerators and cabinets, around plumbing and other utility installations. For ants apply to ant trails, also around doors and windows and wherever else these pests may find entrance.

Note: A period of 4 to 7 days is normally required for maximum effect on cockroaches.

For control of carpet beetles, thoroughly apply as a spray for spot treatment along baseboards and edges of carpeting, under carpeting, rugs and furniture, in closets and on shelving, and wherever else these insects are seen or suspected.

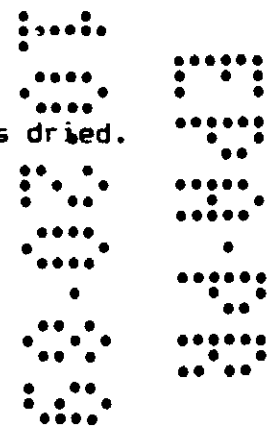

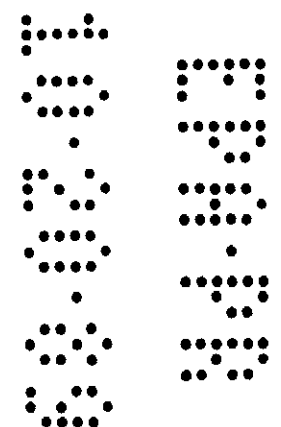
